SAVE MONEY PAYING YOUR TAXES BY DIRECT DEBIT!!

Dear citizen,

We inform you that from 2020 on, you will no longer receive the triptych with the tax payment letter. For that reason, in case you do not wish to pay by direct debit, you will need to go personally to the **Citizen Service Office** at the Town Hall of Alaior to get it.

Linked to this municipal tax campaign, the Town Hall continues promoting **direct debit** of periodical tax fees, as the best way to save time and money to our contributors avoiding unnecessary queues at municipal offices and also providing a significant saving for our citizens.

With direct debit payment, contributors not only benefit from 3 % bonus on IBI receipts and 1,5% on all other receipts, but also save themselves a trip to the Town Hall offices.

Taking full advantage of direct debit tax payment is very simple. Just follow the steps indicated on the back of this page, and present it with a minimum of 1 month before each voluntary period.

We remind you that the first period of voluntary payment for all the yearly municipal taxes begins next March 16th.

We take this opportunity to enclose at the back of this letter, information of your interest about all the municipal taxes for 2020.

Having received this letter means that you have at least one municipal tax without direct debit.

IMPORTANT INFORMATION ABOUT MUNICIPAL TAXES 2020

Payment Period: The dates for voluntary annual payment of municipal taxes are as follows:

PERIOD	DATE	INCLUDES
First period:	March 16 th – May 15 th	Motor Vehicle Tax (IVTM) 50% payment of Personal Property Tax (IBI)
Second period:	July 15 th – Sept. 15 th	Remaining 50% of Personal Property Tax (IBI) Income Tax (IAE) Pet Control Tax, including obligatory vaccination of dogs Waste Management and Treatment Tax Municipal Cemetery Tax Private Entrance for Vehicles Tax Taxi Rank Tax Public Space Occupancy Tax Private Hunting Reserve Tax

Property Tax: Payment plans and bonuses

As in previous tax years, to facilitate the compliance of tax payment by contributors, the IBI personal property tax will be paid in two installments. All contributors meeting the requirements provided by the tax regulator by-law of this tax will be able to apply for the following bonuses before the 31st of December:

- New construction and restoration work for housing development firms, building and real estate development
- Official protection housing and housing which is in compliance with the CAIB regulation.
- Rural property of agrarian cooperatives and community use of land (Regulation 20/1990).
- Large families: Up to 90% bonus based on family income level. Reimbursement will be only on the first 75.000 euros of the property tax value.
- Property where economically profitable activities have to do with special interest groups or municipal use, for social, cultural, historic and/or artistic purposes.
- Property where economically profitable activities of special interest or municipal purposes are carried out when they coincide with the promotion of the activity

Bonus for Direct Debit Payment

3% bonus for Personal Property Tax (IBI)

1.5% bonus for direct debit payment of remaining fees, except in the case of Private Hunting Reserve Tax.

Direct debit payment will be made on 4th of April and 3rd of August, respectively. The deadline for authorizing direct debit payment will be one month before the start of each voluntary payment period: Before 16th of February for the first period or before 15th of June for the second period. Otherwise the authorization will be valid for following periods.

Authorization of direct debit payment may be carried out in person at the Citizen Service office or via the town hall web: alaior.sedelectronica.es, with the use of the contributor's electronic identification or digital certificate. Authorization will be renewed automatically and will be valid indefinitely until cancellation or modification is requested by the person who authorized it.
