

## **Frequent questions**

(This information will be updated and made known to the citizens whenever necessary).

### **1-Can I go for a walk with the dog?**

Yes. Lowering pets into the street is within the mobility exceptions allowed in the Royal Decree Law, taking into account that it must be done individually and maintaining the advisable distance of one and a half meters from the people with whom one casually could find.

### **2-Can I go by bicycle?**

Yes. You can cycle on public roads exclusively for the following activities: buying food, pharmaceuticals and basic necessities, assistance to health centers, travel to the workplace-return to the place of habitual residence, assistance to elderly, minors, dependents and people with disabilities and displacement to financial entities due to force majeure.

### **3-Can I go to the hardware store, the clothing store ...?**

No, if you are an individual. On the other hand, if you develop a wholesale job and that purchase is for your activity, yes you can.

### **4. Can I go to the beach?**

No, since it is not one of the activities that the Royal Decree Law allows.

**5. Can I go shopping?**

Yes, as long as it is at one of the shops where the movement of people is not limited.

**6. Is the time control in the ORA zone still (blue and orange zone) active?**

At the moment it has not been suspended.

**7. Can I go from one municipality to another?**

Yes, as long as it is for one of the reasons why the movement of people is not limited. For example, if you live in Alaior and must go to Mahon to work.

**8. Are the traffic regulations regarding loading and unloading still in force?**

Yes. The traffic regulations regarding loading and unloading are still in force.

**9. Can I go to have coffee at the bar?**

No. All hostelry and restaurant activities have been suspended, only being able to provide services at home.

**10. Can I go fishing?**

No. Fishing is not one of the activities allowed by the Royal Decree Law.

**11. Can I go to the Alaior City Council citizen service office?**

All procedures that can be done electronically ([sac@aj-alaior.org](mailto:sac@aj-alaior.org)) and by phone (971371002) must be done this way. You can only go to the Citizen Services offices for urgent reasons.

**12. Can I go to the mechanic?**

Yes. The car is a permitted mean of transportation, and security conditions must be guaranteed to go to the permitted sites.
